Since the quantum of work is same as previously done for Municipal Councils CDPs and the assignment period and process of approval also delays the entire project duration hence we request you to consider the payment of Rs 10 lacs each for the assignment.</p> <p>2. Please confirm how many consultants does the departments intend to select through this RFP.
